## Board of Director's Nomination Notification

At the 2019 LREA Annual General Meeting there will be three vacancies which will be filled as per the By-law passed at the 2012 AGM. The Board positions are: Derwent (Zone 2) for a 3-year term; Martins (Zone 5) for a 3 year term; and #2 Director at Large for a 3 year term.

Members in good standing will be considered for approval by the Nomination Committee.

## Nomination Process

As described in the by-law, nominations for the office of Director must be submitted to the Secretary of the Association in the 45-day period between July 15<sup>th</sup> and September 1st of the year in question. **Nominations will not be accepted after September 1.** A nomination for Director must have the signature of the candidate certifying that he/she is a "member in good standing" and eligible for election. The member making the nomination must also sign the nomination form indicating that he/she is also a "member in good standing".

Nomination forms will be available at the LREA Ltd. office on July 1<sup>st</sup> of each year and will also include a package of information regarding the duties and obligations of a Board member. This package of information will include the LREA Business Plan, Strategic Plan, Rural Utilities Act and Regulation, a copy of the latest independent audit and a copy of the Board Self-Governance Policy for Code of Conduct & Confidentiality Agreement.
