Annual General Meeting Recap

As the 2020 and 2021 Annual General Meetings were postponed due to COVID-19, we held both AGMs on the evening of March 3, 2022. We had 70 members come out for the meetings despite the stormy evening.

Parliamentarian Pat Knoll was introduced to Chair both meetings with no objection from the membership present.

The 2020 AGM was called to order at 7:03pm.

November 6, 2019, AGM minutes received approval with unanimous consent with no unfinished business.

Member expulsion appeals were held for Dennis Holowaychuk and Kendall Freed. Presentations from Greg Farion (Zone 7 Director) and John Grykuliak (Zone 2 Director) were made on behalf of the Lakeland REA Board. Kendall Freed made presentations as designated agent for Dennis Holowaychuk and for himself. After all presentations were completed, the membership present voted on the expulsion. The voting resulting in the confirmation of the expulsion of both Dennis Holowaychuk and Kendall Freed.

Nomination results for both 2020 and 2021 were read out. Elected by acclamation for 2020: Peter Lazowski (Zone 1), John Homeniuk (Zone 3) and Michael Yakimetz (Zone 4). Elected by acclamation for 2021: Robert Peyton (Zone 6), Greg Farion (Zone 7) and Bernie Klammer (Director at Large #1).

Renee Senko and Brett Boser of Wilde & Company presented 2020 and 2021 respectively. No questions from the floor on either year and audited financials were approved. Wilde and Company were appointed the auditor for the 2021/2022 fiscal year.

Bernie Klammer presented his President's Report. Bernie highlighted the last couple years touching on REA stats, energy rates, scholarships for 2020 and 2021 and the youth leadership program sponsorship.

Darryl Werstniuk presented his General Manager's Report. Darryl touched on the high energy rates encouraging membership to look at their monthly invoices, electricity hedging, the 7L65 project and the supply chain management.

The 2021 AGM was adjourned at 9:06pm.
